- I, Kathy Bazoian Phelps, declare:
- 1. Pursuant to this Court's Revised Order Appointing Receiver, entered on February 28, 2019, I was appointed as the successor receiver ("Receiver") in this case. I am also an attorney duly licensed to practice in the State of California and am senior counsel at the firm of Diamond McCarthy LLP ("Diamond McCarthy"). I have personal knowledge of the matters set forth below and if called as a witness, I would and could testify competently to the matters stated herein.
- 2. This declaration is made in support of the Administrative Motion for an Order Pursuant to Local Rule 7-11 for the Approval of Fees and Expenses for the Receiver and Counsel from December 4, 2020 through March 31, 2020 ("Motion").¹
- 3. Attached hereto as Exhibit "1" is a financial summary of the Receivership Estate for the first quarter 2020, as of March 31, 2020. The financial summary sets forth the cash on hand in the estate.
- 4. Pursuant to my proposal for my appointment, and in recognition of the efficiencies and benefits to the Receivership Estate in my role as Receiver that I can also address legal issues, I have divided my time to date between the following billing categories:

Case Administration (B110)

Asset Analysis and Recovery (B120)

Fee/Employment Applications (B160)

Claims Administration and Objections (B310)

- 5. The detailed time entries reflecting the time spent in each of these categories is attached hereto as Exhibit "2."
 - 6. My standard hourly rate is \$675.00, but I have discounted my hourly rate to \$475.00.

Case Administration

7. With respect to Case Administration, I performed 107.70 hours of services for total fees of \$34,767.60 during the Motion Period.

¹ All capitalized terms used but not otherwise defined herein shall have the meanings given to them in the Motion.

- 8. Since my appointment, I have worked efficiently and economically to move this case forward. During the Motion Period, I have taken actions to manage the administration of the case, including issues dealing with financial reporting, document management and banking. I managed the funds of the Receivership Estate and handled banking and the accounts at East West Bank.
- 9. During the Motion Period, I have continued to communicate with investors who had inquiries on a number of matters including the status of the case and the Receivership Estate, claims, and distribution issues, and created a website for them to easily access necessary information related to the case and their claims. I was also in constant communication with the CFTC by email and telephone concerning facts, background, claim issues, and strategy for moving the case forward. I have also prepared a status report with the Court regarding my activities in the case.

Asset Analysis and Recovery / Asset Disposition

- 10. With respect to Asset Analysis and Recovery, I performed 28.90 hours of services for total fees of \$12,462.50 during the Motion Period.
- 11. During the Motion Period, I evaluated the Receivership Estate's interest in certain securities, companies, and real property including but not limited to: Gain Capital funds; National Gold Mining Corporation ("National Gold"); Sierra Gold, LLC ("Sierra Gold"); and United Resource Holdings Group, Inc. ("URGH") and its subsidiaries Dun Glen Mining Corporation ("Dun Glen") and United Milling & Refining Corp. ("United Milling").
- 12. With respect to National Gold, a private corporation organized in Nevada, and Sierra Gold, a Nevada limited liability company created by the Receivership Defendants and owned with investors, working with my counsel, I reviewed all available materials, spoke with the CFTC, and interviewed the Receivership Defendants to evaluate the Receivership Estate's interest in the shares of National Gold, and how to best monetize those interests.
- 13. With respect to URGH and its subsidiaries Dun Glen and United Milling, during the Motion Period I investigated which assets might be of value to the Receivership Estate, and how that value might best be recovered. For example, certain real property located in Sparks County, Nevada is owned by United Milling, with a deed of trust held by one of Denari's investors. I have

evaluated potential claims against United Milling, transfers made to it and its subsidiaries, and possible resolution. I have communicated with United Milling regarding resolution of claims and those discussions are ongoing.

Fee/Employment Applications

- 14. With respect to Fee/Employment Applications, I performed 9.40 hours of service but have not charged the estate for fees incurred in this category.
- 15. During the Motion Period, I communicated with my retained professionals (general counsel, securities counsel, and tax advisors) regarding their proposed employment, revised the draft administrative motion to employ them in this case, and ensured consent from the CFTC and Receivership Defendants.

Claims Administration and Objection

- 16. With respect to Claims Administration and Objection, I performed 26.00 hours of services for total fees of \$12,350.00.
- 17. During the Motion Period, I devoted a significant amount of time communicating with investors both to investigate possible assets for recovery, and to better understand the nature of their claims. I also worked with counsel to draft the claims bar date motion, and ensure proper service and publication of the claims bar date established by the Court.
- 18. On February 6, 2020, the Court granted the Bar Date Motion and established a claims bar date of April 6, 2020. At the request of the Court, I created a receiver website and published notice of the bar date in the San Francisco Chronicle.
- 19. I have reviewed the claims as they have been submitted and have engaged in extensive communications with many investors regarding their claims in an effort to resolve any discrepancies and issues regarding the claims on a consensual basis. As a result of my efforts, all known customers who were believed to hold claims have submitted claim forms along with one taxing agency.
- 20. There may be a few objections to claims that may be required if I am unable to consensually resolve discrepancies, but otherwise the claims administration has largely been completed.

- 21. I have read the Motion and the billing statements attached to my declaration. To the best of my knowledge, information and belief formed after reasonable inquiry, all the fees and expenses requested in the attached billing statements are true and correct.
- 22. The fees that I and my staff have charged are reasonable, necessary, and commensurate with the skill and experience required for the activity performed. I respectfully submit that neither I nor my staff has expended time unnecessarily and that I have rendered efficient and effective services.
- 23. In connection with services performed, I have also incurred reasonable and necessary costs in the amount of \$1,358.27. A detailed list of the expenses incurred is attached hereto as Exhibit "3." In seeking reimbursement of services for which I purchased or contracted for from a third party, I have only requested reimbursement for the amount billed by the third-party vendor and paid to the vendor. I have not made a profit on such reimbursable services. I have not included in the amount for which reimbursement is sought the amortization of the cost of any investment, equipment, or capital outlay.
- 24. I have conferred with counsel for the CFTC and counsel for the Defendants, and I am advised that they do not oppose the Motion.
