The Receiver is authorized, effective retroactively to December 4, 2019, to employ
 Diamond McCarthy as the Receiver's general counsel based on the Receiver's Motion and the
 Phelps Declaration filed with the Court and in accordance with the terms and at the hourly rates
 described in Exhibit 2 attached to the Phelps Declaration, reduced as set forth in the Phelps
 Declaration.

18 2. The Receiver is authorized to employ Miller Kaplan as the Receiver's tax advisors
19 in accordance the terms and at the discounted rates as described in Exhibit 3 attached to the
20 Phelps Declaration.

3. The Receiver is authorized to employ Schinner as her securities counsel for the
limited services described in the Motion in accordance the terms and at the discounted rates
described in Exhibit 5 attached to the Phelps Declaration.
