Chen Judge: 22 23 24 25 The Temporary Receiver in this matter appointed pursuant to the Court's Order 26 Appointing Receiver (the "Receiver Order") (Doc. No. 37), Kathy Bazoian Phelps (the 27 "Receiver"), requests that the Court grant her Administrative Motion approving the Receiver's 28 employment of (1) Diamond McCarthy LLP ("Diamond McCarthy") as her general counsel; (2)

Miller Kaplan LLP ("Miller Kaplan") as her tax advisor; and (3) Schinner & Shain ("Schinner") as her securities counsel. The Receiver through her declaration dated January 8, 2019 filed in support of the Motion (the "Phelps Declaration"), has represented that she has conferred with counsel for the Commodity Futures Trading Commission and the Defendants, who have confirmed that they do not oppose the Motion.

The Receiver has represented in her Motion and in the Phelps Declaration that she requires the services of these professionals, that she is familiar with the three firms which she seeks to employ, one of which is her law firm, and that they will provide adequate and cost-effective representation based on the services she anticipates them performing and that the professionals have each agreed to perform their services at discounted rates as detailed in the Motion and Phelps Declaration.

GOOD CAUSE APPEARING, IT IS HEREBY ORDERED THAT:

- 1. The Receiver is authorized, effective retroactively to December 4, 2019, to employ Diamond McCarthy as the Receiver's general counsel based on the Receiver's Motion and the Phelps Declaration filed with the Court and in accordance with the terms and at the hourly rates described in **Exhibit 2** attached to the Phelps Declaration, reduced as set forth in the Phelps Declaration.
- 2. The Receiver is authorized to employ Miller Kaplan as the Receiver's tax advisors in accordance the terms and at the discounted rates as described in **Exhibit 3** attached to the Phelps Declaration.
- 3. The Receiver is authorized to employ Schinner as her securities counsel for the limited services described in the Motion in accordance the terms and at the discounted rates described in **Exhibit 5** attached to the Phelps Declaration.

IT IS SO ORDERED.
