I am a partner at the firm of Miller Kaplan Arase LLP ("Miller Kaplan"), tax advisor for the Receiver Kathy Bazoian Phelps in this case. I have personal knowledge of the matters set forth below and if called as a witness, I would and could testify competently to the matters stated herein.

- 2. This declaration is made in support of the Sixth Administrative Motion for an Order Pursuant to Local Rule 7-11 for the Approval of Fees and Expenses for the Receiver, Raines Feldman LLP, Diamond McCarthy LLP and Miller Kaplan from April 1, 2021 to June 30, 2021 ("Motion").
- On February 4, 2020, the Court entered an order (Doc. No. 44) authorizing the Receiver to employ Miller Kaplan as the Receiver's tax advisor ("Employment Order"). I am principally responsible for representing the Receiver in Miller Kaplan's capacity as tax advisors. I directly supervised the professionals and staff of Miller Kaplan with respect to this representation.
- Miller Kaplan was retained by the Receiver for the limited purpose of serving as tax advisors. Miller Kaplan established separate billing categories for services provided: Tax Return Preparation and Filing; and General Consulting. The billing statements itemizing the services provided by Miller Kaplan during the period April 1, 2021 through June 30, 2021 (the "Motion Period") are attached as Exhibit "4."
- In the interests of the estate and pursuant to the Employment Order, Miller Kaplan has agreed to provide its services at the same hourly rates as those provided to SEC fair funds in which Miller Kaplan is appointed as the tax administrator.
- Miller Kaplan performed 5.55 hours of services for fees of \$1,367.60 during the Motion Period.
- Miller Kaplan's services during the Motion Period included advising the Receiver and her counsel certain tax matters, and in finalizing and filing the 2020 qualified settlement fund tax return.
- I have read the Motion and the billing statements attached to this declaration. To the best of my knowledge, information and belief formed after reasonable inquiry, all the fees and expenses requested in the attached billing statements are true and correct.
