Kathy Bazoian Phelps, the successor receiver herein (the "Receiver") of SRA Management Associates, LLC, SRA I, LLC, SRA II, LLC, SRA III, LLC, SRA Management Associates, Clear Sailing Group IV, LLC, Clear Sailing Group V, LLC, Felix Multi-Opportunity Fund I, LLC, Felix Multi-Opportunity Fund II, LLC, Felix Management Associates, LLC, NYPA Fund I, LLC, NYPA Fund II, LLC, NYPA Management Associates, LLC and Solis Associates Fund LLC, hereby files this Administrative Motion under Local Civil Rule 7-11 (the "Motion") for Order resetting the deadlines to respond to the Receiver's Motion for Order Authorizing Modification of the Distribution Plan (Doc. No. 704).

RELIEF REQUESTED

The Receiver filed her Motion for Order Authorizing Modification of the Distribution Plan on July 27, 2023 (Doc. No. 704) (the "Motion to Modify the Plan"). The Notice of Hearing on the Motion to Modify the Plan provided notice that a hearing on the motion would take place on August 31, 2023 and provided further notice that any opposition to the motion must be filed no later than August 10, 2023 (Doc. No. 705).

On August 1, 2023, the Court issued an Order rescheduling the hearing on the Motion to Modify the Plan to October 26, 2023 (Doc. No. 706). The Receiver believes that it is appropriate to provide interested parties additional time to file a response to the Motion to Modify the Plan given the rescheduling of the hearing on the Motion. Accordingly, the Receiver asks this Court to also issue an Order setting a new date by which any response to the Motion to Modify the Plan must be filed and setting a new date by which any reply must be filed.

The Receiver suggests a deadline for any opposition to the Motion to Modify the Plan be set for September 28, 2023 and that any reply be filed no later than October 12, 2023.
