general counsel. The Receiver through her declaration has represented that she has conferred with counsel for the Securities and Exchange Commission and counsel for Progresso Ventures, who have each confirmed that they do not oppose the Motion.

The Receiver has represented in her Motion and declaration that she has changed law firms along with the lawyer primarily in charge of her representation, that Raines Feldman is well qualified to serve as her counsel, and that the firm will provide adequate and cost-effective representation based on the services she anticipates them performing and that Raines Feldman has agreed to perform their services at discounted rates as detailed in the Motion and supporting Declaration of David Castleman filed in support of the Motion.

GOOD CAUSE APPEARING, IT IS HEREBY ORDERED THAT:

- 1. The Receiver is authorized, effective retroactively to April 23, 2021, to substitute in Raines Feldman as her general counsel and to employ the Firm as the Receiver's general counsel on the terms set forth in the Motion.
- 2. The adjusted rates for the Receiver and Raines Feldman as set forth in the Motion are approved.
- 3. The employment of Diamond McCarthy is deemed terminated as of April 22, 2021.
