DEC. OF JNICHOLAS SANCHEZ ISO NINTH ADMIN MOTION FOR FEES AND EXPENSES

I, Nicholas Sanchez, declare:

- 1. I am a partner at the firm of Miller Kaplan Arase LLP ("Miller Kaplan"), tax advisor for the Receiver Kathy Bazoian Phelps in this case. I have personal knowledge of the matters set forth below and if called as a witness, I would and could testify competently to the matters stated herein.
- 2. This declaration is made in support of the Ninth Administrative Motion for an Order Pursuant to Local Rule 7-11 for the Approval of Fees and Expenses for the Receiver, Raines Feldman LLP, and Miller Kaplan from October 1, 2022 through December 31, 2023 ("Motion").
- 3. On February 4, 2020, the Court entered an order (Doc. No. 44) authorizing the Receiver to employ Miller Kaplan as the Receiver's tax advisor ("Employment Order"). I am principally responsible for representing the Receiver in Miller Kaplan's capacity as tax advisors. I directly supervised the professionals and staff of Miller Kaplan with respect to this representation.
- 4. Miller Kaplan was retained by the Receiver for the limited purpose of serving as tax advisors. Miller Kaplan established separate billing categories for services provided: Tax Return Preparation and Filing; and General Consulting. The billing statements itemizing the services provided by Miller Kaplan during the period October 1, 2022 through December 31, 2023 (the "Motion Period") are attached as Exhibit "4."
- 5. In the interests of the estate and pursuant to the Employment Order, Miller Kaplan has agreed to provide its services at the same hourly rates as those provided to SEC fair funds in which Miller Kaplan is appointed as the tax administrator.
- 6. Miller Kaplan performed a total of 5.50 hours of services for fees of \$3,360.40 during the Motion Period.
- 7. During the Motion Period, Miller Kaplan performed the Preparation and Filing of the 2022 Qualified Settlement Fund Income Tax Return for a total of \$2,500.00, a flat fee.
 - 8. During the Motion Period, Miller Kaplan performed 0.40 hours in the category

of Information Return Reporting Services for a total of \$83.20 in fees.

- 9. During the Motion Period, Miller Kaplan performed 5.10 hours in the category of Qualified Settlement Fund Services, including preparing estimated 2023 quarterly tax payments, for a total of \$777.20.
- 10. During the Motion Period, Miller Kaplan incurred \$50.00 in costs including information reporting forms.
- 11. I have read the Motion and the billing statements attached to this declaration. To the best of my knowledge, information and belief formed after reasonable inquiry, all the fees and expenses requested in the attached billing statements are true and correct.
- 12. The fees that Miller Kaplan has charged are limited, reasonable, necessary, and commensurate with the skill and experience required for the activity performed. Miller Kaplan's services and time expenditures are reasonable in light of the labor required for the matters for which Miller Kaplan was retained and the balancing that must be performed to efficiently and effectively represent the Receiver in the limited capacity as tax advisors. Miller Kaplan respectfully submits that it has not expended time unnecessarily and that it has rendered efficient and effective services.
